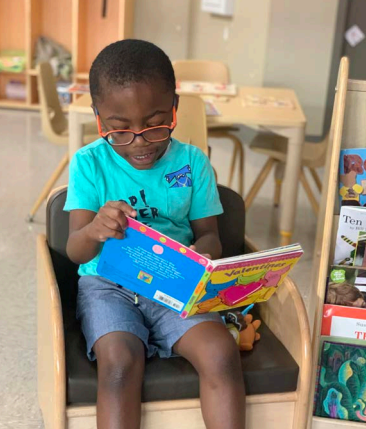
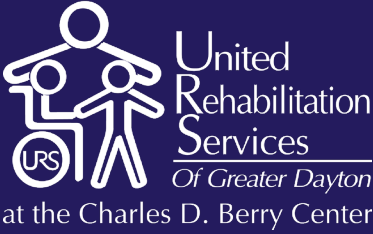


# UNITED REHABILITATION SERVICES GIVING CIRCLE 2022
